## IMPORTANT BENEFIT PLAN CHANGES

The Trustees of the Automobile Mechanics' Local No. 701 Union and Industry Welfare Fund have made certain changes to the **Premier Plus**, **Premier**, and **Pre-Medicare Retirees** plans (collectively, the "Plans") as documented in the applicable combination Summary Plan Description and Plan Document ("SPD/Plan") that was previously provided to you. Each change is summarized below and is effective as of the date indicated below.

1. The **Premier Plus**, **Premier** and **Pre-Medicare Retirees** Plans were amended to add up to 12 nutritional counseling visits per year as a covered benefit, effective as of October 1, 2023.
2. The **Premier Plus**, **Premier**, and **Pre-Medicare Retirees** Plans were amended to remove Humira from the Specialty List and thereby exclude it from coverage under the Plan, except for pediatric doses, effective as of January 1, 2024.

## SUMMARY OF MATERIAL MODIFICATIONS

### **1. Addition of 12 Nutritional Counseling Visits Per Year**

The **Premier Plus, Premier** and **Pre-Medicare Retirees** Plans added coverage for nutritional counseling, but limited it to 12 visits per Plan Year and requires that the covered individual be referred by a licensed Physician prior to being covered and that only nutritional counseling sessions with a Physician, licensed nutritionist, or registered dietician provider will be covered. Accordingly, effective October 1, 2023, the Schedule of Benefits tables in the SPD/Plans were updated to reflect this change as follows:

<sup>1</sup> Must be referred by a licensed Physician prior to being covered. Only visits with a Physician, licensed Nutritionist, or registered dietician provider will be covered.

### **2. Remove Humira From Specialty List and Coverage, Except For Pediatric Doses**

The **Premier Plus, Premier** and **Pre-Medicare Retirees** Plans modified the Specialty List under the Plan to remove the prescription drug Humira and exclude it from coverage under the Plan, except for pediatric doses, effective January 1, 2024.
